PREVIOUS MINUTES: Minutes of the 5.13.2020 regular board meeting are approved as distributed: **MSP** (motion made, seconded, and passed; the vote is unanimous unless otherwise indicated).

TREASURER'S REPORT: The current balance is \$40,487.43; three checks: \$88, \$114, \$163 have not yet cleared.

2020/2021 Budget (Second Reading): After discussion, the 2020/2021 budget was approved as presented: **MSP** (copy attached).

ROAD IMPROVEMENT

<u>Committee Report</u>: Preliminary results of the recent survey sent to property owners are: 82 responses received (57% response rate so far); Question 1: 57 support; 25 oppose. Question 2: 19 pay up front; 6 pay some up front and some over time; 6 pay the entire amount over time. Question 3: 9 want 10 years; 2 want 15 years; 7 want 20 years.

Next Letter to Property Owners and Next Survey: Points that were raised during the discussion:

- The next letter should be shorter and the survey should be on the first page.
- Information on financing needs to be included.
- We need to be able to follow up on non-responders.
- We need some way to avoid foreclosure on properties in arrears on lien payments.

Nyle checked with a title/escrow service. They are not prepared to handle the preparing and recording of liens.

Requirements for possible road improvements: The Otta Seal bid and all the asphalt bids received are based on McCoy Engineering specifications.

All the asphalt bids received were based on the McCoy Engineering specifications which specify:

- All roads currently maintained in the district are included: paving 20' width with 2' shoulders.
- All bids include grinding, grading and reshaping the "grindings" portions of Panoramic and east Buck Horn.
- All bids include raising the grade of Emerald Valley so ensure that water drains off the road. This
 includes the extension of Emerald Valley outside PASRD boundaries to Hurtley Ranch Rd.

- All bids include drainage repair where Green Ridge meets Panoramic and the downhill portion of Panoramic to Hinkle Butte.
- The Lake extension (12' wide) is included as far as 69700 Lake Dr.

It is the intention of the Board that a single contractor would be responsible for the entire road improvement project to avoid any finger pointing between multiple contractors.

Annie will videotape a road tour of the Otta Seal roads identified by Jim and make the video available.

ROAD MAINTENANCE

A tree is partially blocking the road at the bottom of Panoramic. Nyle will follow up.

ADMINISTRATIVE

<u>Website report/status</u>: Meeting minutes and the current letter and survey to property owners are on the website. Whitney requested that only one board member OK the posting of materials on the website in order to eliminate confusion. Nyle designated Annie as the point of contact for the board.
