**A resident attempted to bypass the board and put Chip Seal on Green Ridge Loop. It was stopped and the resident was informed they must submit a request to the board to pursue any work to be done on the roads outside of their property. Any connection to the pavement on Green Ridge Loop will have to be pavement no Chip Seal.**
